**Item 9. Other Events**

We advise the Commission that on September 24, 2025, the Company informed the Philippine Stock Exchange and the investing public that the legal representatives of Mr. Joseph C. Sy have received a copy of the Resolution of the CA in relation to the habeas corpus proceedings.

The CA, in its Resolution, ordered the officials of the Bureau of Immigration (BI) and/or any custodian of Mr. Sy "TO IMMEDIATELY RELEASE Joseph Cue Sy from detention, under pain of contempt, and TO NOTIFY the Court of their action within five (5) days from receipt of the Resolution."

This clear directive from the CA not only reinforces the earlier Decision of the Regional Trial Court of Taguig City affirming Mr. Sy's Filipino citizenship and declaring that the BI has no jurisdiction to detain him, but also supports the long-standing legal presumption in favor of his Filipino citizenship.
