**Item 9. Other Events**

We advise the Commission that on September 25, 2025, the Company made a news clarification with the Philippine Stock Exchange:

The Exchange requested the Company to make a clarification to various news articles relating to Global Ferronickel Holdings, Inc. ("FNI" or the "Company"). In the attached news article entitled "Joseph Sy standoff continues: Court says release, BI says no as case heads to SC" posted in Bilyonaryo.com on September 24, 2025, it was reported in part that:

"The Bureau of Immigration will not release mining magnate Joseph Sy despite an order by the Court of Appeals directing it to do so, as it elevates the case to the Supreme Court.

The Court of Appeals has junked the BI's appeal for lack of merit and ordered BI Commissioner Joel Anthony Viado, NAIA-Bureau of Immigration Intelligence Department Ant-Tourism Group member Gene Bermudo, and anyone currently in custody of Sy to immediately release him from detention under pain of contempt, and to notify the court of their actions within five days of receiving the order.

"We will be coordinating with the DOJ and the OSG [Office of the Solicitor General] to avail of the available legal remedies for this case," the BI said, insisting that it has strong evidence supporting Sy's deportation case, backed by biometric records.

Sy, owner of Global Ferronickel, has been detained at Camp Bagong Diwa after his arrest at Ninoy Aquino International Airport on August 21 for allegedly falsifying his Filipino citizenship.

In response to the request of the Exchange and with reference to a recent news article regarding Mr. Joseph C. Sy, the Company clarifies that it has not received any official notification that the Bureau of Immigration (BI) has elevated the case to the Supreme Court of the Philippines. The Company will disclose any official developments as they arise.

As previously disclosed, the Court of Appeals (CA), in its Resolution, ordered the BI and/or any custodian of Mr. Sy “TO IMMEDIATELY RELEASE Joseph Cue Sy from detention, under pain of contempt, and TO NOTIFY the Court of their action within five (5) days from receipt of the Resolution.” While, the BI has yet to comply with this directive, the Company views this development as a strong affirmation of the rule of law and the constitutional protection guaranteed by the writ of habeas corpus. It underscores that the rights of citizens are safeguarded against overreach and that judicial institutions remain firm in upholding established legal principles.

This Resolution also brings clarity and stability by confirming the consistency of judicial rulings on Mr. Sy’s citizenship and release. The Company’s operations remain stable and unaffected, with management focused on delivering value to shareholders and stakeholders.
