Change of indirect of shareholding pursuant to the November 5, 2025 disclosure.

After subscribing to unissued shares of Blue Eagle Elite Ventures, Inc., Ultimate Horizon Capital, Inc., and Sohoton Synergy, Inc., Ms. Mary Belle D. Bituin now holds majority interests in these companies. She likewise holds nominal interests in Great South Group Ventures, Inc. and Red Lion Fortune Group, Inc.

In turn, Blue Eagle Elite Ventures, Inc. is the majority shareholder of Regulus Best Nickel Holdings, Inc., Alpha Centauri Fortune Group, Inc., and Bellatrix Star, Inc.

Based on her shareholdings in these entities, Ms. Bituin has an indirect interest equivalent to approximately 31.49% of FNI, or about 1,615,398,639 shares. Mr. Joseph C. Sy has an indirect interest equivalent to approximately 5.73% of FNI, or about 293,528,449 shares.
